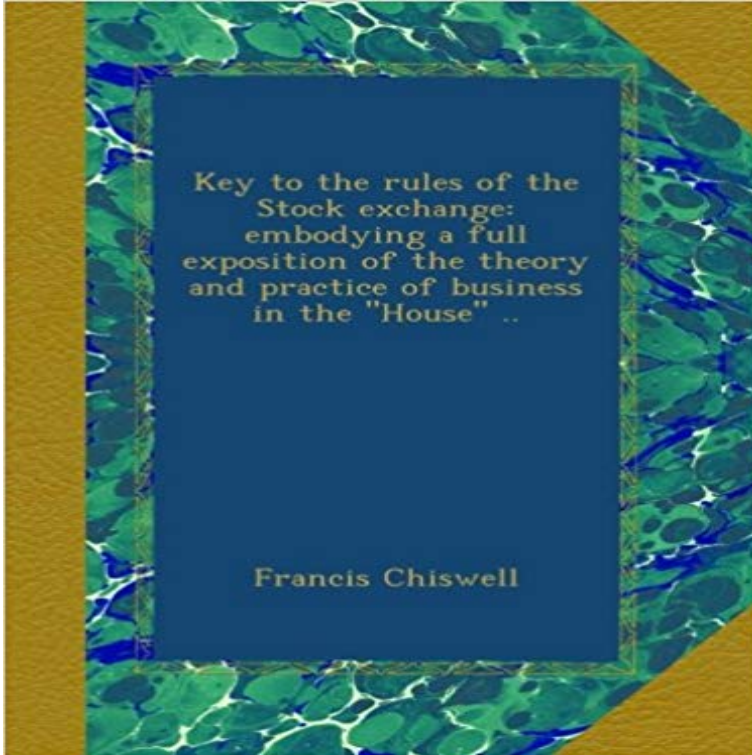


Key to the rules of the Stock exchange: embodying a full exposition of the theory and practice of business in the House ..
